THE FUND MAINTAINS A WEBSITE THAT ATTRACTS INDIVIDUAL DONORS AND IS LISTED ON EMPLOYEE MATCHING DONATION PROGRAMS FOR SEVERAL LARGE CORPORATIONS INCLUDING BANK OF AMERICA, CHEVRON, AND APPLE. THE FUND ALSO PARTICIPATES IN FUNDRAISING PROGRAMS SUCH AS BENEVITY.

IN ADDITION, THE FUND HAS A CLOSE PARTNERSHIP WITH (RED) (WWW.RED.ORG), A PROGRAM OF THE US-BASED CHARITY ONE CAMPAIGN (WWW.ONE.ORG), WHICH SEEKS TO RAISE FUNDS THROUGH INDIVIDUAL AND CORPORATE DONORS ON OUR BEHALF. THIS IS ACCOMPLISHED THROUGH AN AGREEMENT THAT ALLOWS RED TO SOLICIT AND COLLECT FUNDS ON OUR BEHALF. THESE RANGE FROM MASSIVE INDIVIDUAL GIVING CAMPAIGNS TO COMMERCIAL CO-VENTURES AND CORPORATE DONATIONS. THIS WORK IS ONGOING AND HAS A BROAD REACH ACROSS THE UNITED STATES AS WELL AS INTERNATIONALLY.

TOGETHER THESE DIFFERENT FUNDRAISING CHANNELS HAVE RAISED MILLIONS OF DOLLARS FROM HUNDREDS OF INDIVIDUALS AND BUSINESSES, OBTAINING BROAD PUBLIC SUPPORT THAT ALLOWS US TO CONTRIBUTE TO THE WORK OF THE GLOBAL FUND TO FIGHT AIDS, TUBERCULOSIS, AND MALARIA, A SWISS FOUNDATION RECOGNIZED BY THE UNITED STATES AS A "PUBLIC INTERNATIONAL ORGANIZATION".
